Impact of Research Dissemination and Knowledge Exchange Activities

In 1995, we published the Pain Catastrophizing Scale (PCS). The PCS has been translated into 30 languages and has been incorporated in the clinical assessment protocols of pain clinics and rehabilitation centres around the world. The paper describing the development of the PCS (Sullivan et al., 1995) has been cited over 8400 times; a theory paper addressing the processes underlying pain catastrophizing (Sullivan et al 2001) has been cited over 3000 times and was listed as one of the top 5 citation classics in pain research between 2000 and 2010 (J Anesth (2012) 26:85–93).

In 2008, we published the Injustice Experiences Questionnaire (IEQ; Sullivan et al., 2008). The publication of this scale prompted hundreds of studies examining the deleterious effects of injustice appraisals on recovery trajectories following debilitating injury. Our work on psychosocial risk factors for delayed recovery has played an important role in treatment-related policy for numerous injury insurers and workers compensation boards such as SIRA (AU), Labor and Industry (USA), WSIB, CNESST and WorkSafe BC (Canada). Our research on psychological predictors of adverse recovery outcomes reflects successful efforts to work collaboratively with varied agencies and user groups to maximize the scientific and clinical impact of research findings.
